#### Remarks:

- 1. Students should wear proper PE uniforms.
- 2. Lunch is not included in the trip. Students should bring enough drinking water and sunscreens and an umbrella.
- 3. The project learning activity aforementioned is a school activity which all students must attend. If a student is absent due to illness, a medical certificate from registered medical practitioner is required. Otherwise, it would be treated as truancy. Any student not participating due to special reasons has to get school's approval in advance and return to school for revision.
- 4. 25th November (Friday) is a school holiday. Students are not required to attend school.

#### Information on Life Wide Learning Activity (S3-S6)

- 1. Following the guidelines on "Health Protection Measures for the Prevention of COVID-19 for Schools" issued by the Education Bureau, all participants have to use the "LeaveHomeSafe" mobile application to scan the QR codes for record and have it displayed when boarding transportation and entering premises (including attractions). Students who fail to fulfill the requirements have to apply to the class teacher in advance and return to school for self-study that day.
- 2. When getting on and off the coach, students should be careful and follow the instructions of teachers to behave properly.
- 3. On board, students should stay in seat quietly and keep the coach clean. Students are prohibited to push the door or other equipment of the coach.
- 4. Students must bring their student card and identity card and follow the instructions of teachers. Students should pay attention to safety, and should not leave the team or travel alone without permission.
- 5. Students should protect animals and plants in the natural environment.
- 6. Students should not bring large amount of cash or valuables. Students should also take care of their personal belongings to prevent unnecessary loss.
- 7. Students should follow the school rules and regulations.
